CULTURAL REFERENCE

This year MSAL and Toulouse 1 Capitole University (France) are actively negotiating an agreement on the network form of implementation of educational programs at the bachelor's level. The package of bilateral agreements will allow Russian students (during their undergraduate studies) to also get a licentiate level at French higher education institutions. It will be possible due to the fact that two years out of four they will study at our partner university with full immersion in the language and cultural environment of another country. French students will also have equal opportunities: they will spend half of their studies "on a visit" and will be able to get a diploma of higher education at MSAL.





CULTURAL REFERENCE

France is one of the most symbolic countries on the planet. Each province, town, village, castle, vineyard, and even any public association has its own coat of arms, flag, motto, and other aesthetic attributes. Numerous national symbols are associated with The French Revolution (XVIIIth century), the French flag (tricolour) the vertical stripes of which have their own meaning (the white is associated with the monarchy, the red - with the republic, and the blue represents Charlemagne, Clovis and other early rulers of the country), the Marseillaise (the national anthem since 1946, although it has been used much longer - since July 30, 1792, when the militia of the revolutionary Marseille entered Paris) and the famous "Gallic rooster" - an unofficial symbol of the country since the era of Renaissance. Another well-recognized symbol of the country is the female figure of Marianne which portrays the republic as the motherland and personifies the motto "Freedom, Equality, Fraternity".

CULTURAL REFERENCE

At the age of six, children start primary school (also known as ecole primaire), where they study basic skills of reading, writing and arithmetic. Approximately at the age of eleven, the high school (college) period begins and lasts for four years. Then education continues in specialized schools of higher level (lycee d'enseignement general et technologique or lycee professionnel). Graduates of such schools receive bachelor's degree (Baccalaureat general или Baccalaureat technologique) which is necessary for admission to a university or technical school.




After graduation from the technical and vocational school, a certificate of professional training (Certificat d'Aptitude profe ssionnelle) or a diploma with the right to enter the university (Brevet d'Etudes professionnelles) is issued.


After graduation from the university, a bachelor's degree in a particular professional field (Baccalaureat professionnel) is awarded.

Contrary to popular belief, obtaining a bachelor's degree in France is quite a serious challenge. Those who do not pass the exams for the course can be left for the second year or prepare and pass the exams on their own, but again - not earlier than a year later. It is important to note that it is impossible to admit to the university without a bachelor's degree.

The French higher educational system consists of universities, higher schools (grandes ecoles) and institutions of advanced training. In France, there are currently more than 70 universities, graduates of which receive diplomas on basic higher education (diplome d'Etudes universitaires generals) after two years of study, diploma of completion of three university courses (licence) and Master's degree (maitrise) which is the full course of study.

French higher schools (grand ecoles) are elite educational institutes with highly competitive admission requirements based on the exam. Successful completion of such an educational institution guarantees good career prospects in any sector of the economy since the level of teaching there is usually higher than in universities ensures a pronounced professional specialization.






In French "étiquette" means both "etiquette" and "ceremony". And indeed, formalities, traditions and rituals are given quite a lot of attention there.

Due to the abundance of all sorts of unspoken rules and regulation many foreigners compare France with Japan. But this is another cliche, an outer shell that immediately catches the eye of a foreigner only because of the special national character of the country. In fact, the French are as democratic and open as any other nation of the Western Europe. They simply used to turn even the most insignificant event into a mini-performance - a trait which can also be easily found in Italians or Spaniards, for example. If you have the common tact, it is no more difficult to communicate with French than with any other European.

CULTURAL REFERENCE

While maintaining a general emphatically polite attitude to others it is not customary to smile at strangers in public places. Also, many foreigners note that the French try not to look into the eyes of unfamiliar people and by no means do they raise their voices in a conversation. At the same time, when visiting a store or cafe, the guest must greet the owner immediately after entering, and the owner of the establishment usually responds in the same way, even if he is not familiar with the customer. It is also unthinkable for a Frenchman to start a conversation with a stranger (for example, to help choose a product or order a dish) without a preliminary greeting.




